3 Vendor Pre-Requisites

The vendor shall fulfil the following requirements to be eligible for short-listing for issue of RFP.

a) Should be a Registered Firm and not an Individual. The vendor shall be a single entity/registered as a Company/Firm/Society under respective Acts in India and should fully own and maintain pre-press, printing

- and post-press facilities, as mentioned in Annexure-A- Clause:15 of this document, located in Thiruvananthapuram Corporation.
- b) Should have valid registration certificate issued by any Government Agency. The Bye-Law/Registration Certificate should permit undertaking the proposed work.
- c) Should have minimum 3 years of experience in high quality 4 colour (CMYK) printing
- d) Should have Income Tax (PAN) and GST Registration.
- e) Should **NOT** have been blacklisted by any Central/State government-owned or government-controlled entity
- f) Should **NOT** have any of their Directors and Officers convicted of any criminal offence related to professional misconduct or making of false statements or misrepresentations with respect to their qualifications to enter into a procurement Contract within a period of two years preceding the commencement of the procurement process, or not otherwise have been disqualified pursuant to debarment proceedings

4 Selection Process for Pre-Qualification of Vendor

The Vendor will be shortlisted based on:

- i. The compliance of all the pre-requisites as in 3 above
- ii. Complying with all the Terms and Conditions.
- iii. Evaluation of the vendor by an appropriate Committee

In the absence of non-availability of any of the documents sought for, the EoI will NOT be considered and <u>no clarification will be sought for by VSSC</u>

5. EOI Terms and Conditions

5.1. Definitions

- 5.1.1. 5.3. Period of Contract:

5.4. Submission of Forged Documents
