1. Background

Shri Manoj Kumar Asawal, Add-vill-Randhisar, Tehsil-Sujangarh, Dist-Churu (Rajasthan), Pin:331 505 vide application dated 28.02.2020 has sought information related to the Advt. No. VSSC-305 dated 22.12.2018, Post No.1393-Fitter in 4 queries. After collecting relevant information from the custodian of records, CPIO vide letter dated 08.05.2020 has furnished the information to the appellant. A copy of the reply letter was sent to the appellant on 11.05.2020 through e-mail. However, an appeal dated 04.05.2020 was received from the appellant on 28.05.2020.

2. Prayers in the appeal

The appellant alleged that he has not received any response against his RTI application within the specified time limit.

3. निर्णय/DECISION

On perusal of the records brought before me, it is observed that CPIO has furnished the reply vide letter dated 08.05.2020. A copy of the reply was sent to the appellant on 11.05.2020 through e-mail. It is observed that the delay occurred is due to lock down declared by the Government as preventive measure to contain the spread of COVID-19. Since the information has already been furnished, the appeal petition is closed.
