1. Background

Shri Harisankar R, Pezzhuvilla Veedu, 28th Mile, Vettiyara P O, Pin: 695 603 vide application dated 05.01.2020 (received by CPIO on 06.01.2020) has sought information on the recruitment to the post of Catering Attendant –A (Advt No.305, Post No.1405) viz. the details of candidates selected for Skill Test and mark obtained by them, date of publication of final result and the details of appointments. After having collected relevant information from the custodian of records, CPIO vide letter dated 24.01.2020 has informed the applicant that as the selection process for the post of Catering Attendant –A (Advt. No.305, Post No.1405) is not yet completed, the details of candidates selected for Skill Test and mark obtained by them could not be furnished now. Further, regarding the date of publication of final result, it was informed that final result will be published in the VSSC website as soon as the selection process gets completed. For the question regarding the details of appointments, it was informed that no appointments were made for the post. Being not satisfied with the reply furnished by CPIO, the appellant has filed an appeal dated 06.07.2020 before the undersigned.

2. Prayers in the appeal

The appellant alleged that CPIO has provided incomplete, misleading or false information.

3. निर्णय/DECISION

On perusal of the records brought before me, it is observed that the appellant has sought information on the recruitment to the post of Catering Attendant –A (Advt. No.305, Post No.1405). It is noticed that the selection process for the said post was not completed at the time of submission of the RTI

application. Hence, the disclosure of the information, sought by the appellant, regarding the details of candidates selected for Skill Test and mark obtained by them could not be possible at that stage. In this context, it is observed that the selection process for recruitment is a sensitive exercise and premature revelation of any information to a particular candidate or person will harm the competitive position of other candidates. In view of the above, I hold that the reply given by the CPIO was in order.

4. Regarding the queries for providing the date of publication of final result and the details of appointments made for the post, the information provided by CPIO was satisfactory as the selection process was not completed at the time of dissemination of information to the appellant.
5. In this regard, it is observed that the Competent Authority has cancelled the entire selection process for the recruitment to the post of Catering Attendant-A due to administrative reasons and this fact is posted in the VSSC website for information of all concerned. Since, the selection process has been cancelled, the information sought by the appellant has lost its significance.
6. A second appeal against this decision lies with the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067, within ninety days from the date on which this decision is received.
7. This Appeal is disposed of at Thiruvananthapuram on the 17th day of September, 2020.
