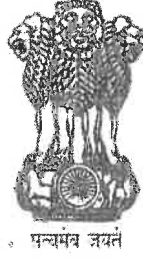

## **Annexure**

### **Guidelines**

1. Public are allowed to visit the VSSC space museum from 9.30 hrs to 16.00 hrs on all days except Sundays and declared holidays (notified on the calendar available online). The entry is allowed without any fee.
2. Sounding rockets are generally launched from TERLS on every third Wednesday at 11.45 hrs (subject to change for technical reasons) for scientific purposes. Those who wish to witness the launch should be present at space museum before 10.30 hrs.
3. Normally the entry is allowed only for Indian nationals only. However, foreign nationals are also allowed against special permit issued by Administrative Officer, Public Relations, and VSSC with the approval of Director, VSSC, for which they have to apply well in advance and as per MHA guidelines. However entry is granted only for Business Visa holders.
4. The interested Indian nationals can apply online (website: [www.vssc.gov.in](http://www.vssc.gov.in)), maximum 3 months in advance. Online request will be processed only on working days.
5. The request can be for an individual or for a group. The individual/group leader should furnish the following details.
  - Name, age, occupation, address, and mobile number.
  - Proof of Identity (Voters ID/Aadhar card/driving license/passport/id-card issued by government organisation).
  - Name and age of other individuals in the group.
6. The group leader should be invariably present at VSSC on the day of visit and will be responsible for the integrity and disciplined behaviour of the group.
7. For every online request, the system will acknowledge with a unique id. This id can be used to cheque the status of the request online and also to get the printed entry pass on arrival at VSSC.
8. VSSC will process the online request for approval. On approval, intimation will be given by email and SMS.
9. Printed entry pass can be obtained either from PRO, VSSC near Veli Church or from the security gate at Canal gate, near Stationkadavu at the northern boundary of the VSSC campus. 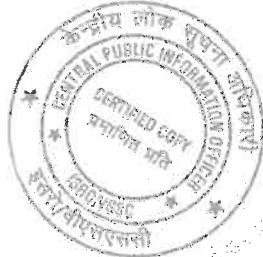

OFFICE MEMORANDUM

The subject of considering leave of absence for various reasons of personnel for the purpose of computing residency period for review under Merit Promotion Scheme, was discussed during the 99<sup>th</sup> and 100<sup>th</sup> meetings of the ISRO Council. Based on the recommendations of the Special Committee constituted for the purpose and approval of ISRO Council, the following procedure for computation of residency period are implemented until further orders:

- (i) For those personnel who have absented from duty at a stretch or in cumulative spells a period not exceeding 180 days in a given review period, such period shall be treated as duty for the purpose of computing the residency period for review to the next higher grade.
  - (ii) For those personnel who have absented themselves from duty for various reasons at a stretch or in cumulative spells for a period exceeding 180 days on a rationalized period of review during the review period, 50% of such period of absence shall be loaded to the residency period and review date of such employee shall be stretched for deciding the rationalized date of review.
  - (iii) For all women employees, the period of absence due to sanctioned Maternity Leave, excluding other types of leave taken alongwith Maternity Leave, shall be treated as duty for arriving at the residency period for review.
  - (iv) For promotion of personnel under MPS, the grace period of three months as contained in OM No.HQ:ADMN:4.20(3) dated 17.12.1977, shall not be adjusted against the period of absence for reckoning the residency period for review for next higher grade and next immediate rationalized date shall be reckoned for the purpose.
2. The order shall be effective from the rationalized date of 01.07.2015.

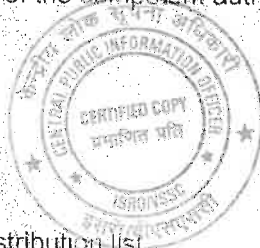

In continuation of Office Memorandum No. HQ.ADMN:A.20(2)/2014, dated December 29, 2014 regarding computing the residency period under Merit Promotion Scheme in respect of leave of absence availed by personnel. It is hereby informed that the following two conditions are applicable in addition to the existing four conditions.

- v) In OM No.HQ.ADMN:4.20(1) dated 25.04.1977, and OM No. 2/2(8)/86-I dated 10.09.1986, relevant to the above cited subject, it is stipulated that the entire period spent by an employee on study leave, including other kinds of leave/if any, combined, shall be counted for the purpose of review and promotion in accordance with DOS/ISRO norms and orders in force and as amended from time to time. In partial modification of the above said OMs, henceforth, **for all kinds of study leave including sponsorship taken by an employee at a stretch or in cumulative spells for a period exceeding 180 days on a rationalized period of review during the review period, 50% of such period of absence shall be loaded to the residency period, and review date of such employee shall be stretched for deciding the rationalized date of review.**
- vi) As per the extant provisions governing Qualifying service, Extra-ordinary Leave (EOL), taken by the employee on account of Personal grounds i.e. without Medical Certificate is not counted as qualifying service. In concurrence with these provisions, **the entire period of EOL taken on account of Personal grounds shall be loaded to the residency period and review date of the employee to be decided after stretching the residency period accordingly.**


