SCOPE OF WORKS, TERMS AND CONDITIONS

1. Scope of work:

Modification of interior of load cabin & driver cabin ofForce make delivery van and installation of air conditioning system on it as per the specification mentioned in annexure-1, Scope of work, terms and conditions in Annexure-2.A design drawing for the modification work shall be prepared and submitted along with the bid.

2. Collection of delivery van and return after completion of modification work

- Registered vehicle for modification shall be collected from VSSC,
 Thiruvananthapuram by the Service provider/ Body fabricator.
- ii. Bank guarantee/all risk insurance policy for the value of the delivery van (approx. Rs. 14.00 lakh per vehicle) shall be submitted by the successful bidder/body fabricator before taking the vehicle from VSSC for modification works. Bank guarantee will be returned back only after the successful completion & acceptance of work and delivery of the vehicle safely at VSSC site. In case of submission of all risk insurance policies in lieu of bank guarantee, the validity of the insurance policy must extend beyond the maximum delivery period.
- iii. For the intermediate movement of delivery van within the work centre and outside the work centre for carrying out the work mentioned in annexure-1 shall be under the scope of Service provider/body fabricator. Prior approval shall be obtained from VSSC for moving the vehicle from body builder work center to A/C installation work center of third party & back. Delivery van shall not be used for any other purpose other than this.
- iv. After modification work and final clearance from VSSC, the vehicle shall be delivered back to VSSC, Thumba, Thiruvananthapuram by the Service provider/ Body fabricator.
- v. Vehicle for modification works will be allotted by VSSC on all three vehicles simultaneously, sequentially (one after another), **or** in phases (initially on one vehicle and then on the remaining two vehicles after completion of the first) based on demand and availability to spare the vehicle. So, Body fabricator shall collect & carryout the work on the vehicle accordingly.
- vi. Being a Govt. of India organization, the vehicle is exempted from taking insurance and no insurance is taken by VSSC side so far. Hence, the Service Provider/ body fabricator is held responsible for the safe transportation, modification and delivery back to VSSC

3. Milestone events & Delivery schedule

- I. Submission of detailed drawings (Bidder scope): Within 10 days from the date of acceptance of purchase order.
- II. Submission of bank guarantee or all risk insurance policy (Bidder scope): Within 10 days from the date of acceptance of final fabrication drawing by VSSC.

- III. **Intimation of vehicle readiness** (VSSC Scope):- Readiness of the vehicle(based on internal demand/ possibility to spare the vehicle) for modification work will be intimated by VSSC.
- IV. **Collection of vehicle from VSSC:** Within 5days from the date of intimation of vehicle readiness received from VSSC.
- V. Delivery of modified vehicle to VSSC (Bidder scope):Within 95 days from the date of intimation of each vehicles readiness communicated by VSSC excluding the time taken for inspection by VSSC after the receipt of inspection call letter.

4. Inspection

Normally 3 stage inspection will be carried oot by VSSC.

First stage: -After driver cabin and load cabin separation work and tool box cum berth provision work; but, before partition paneling work.

Second stage:- After paneling work on driver cabin and load cabin and rooting of ac duct.

Third stage:- Final inspection after all work including installation of air conditioning system. Road testing and ac performance will be analyzed during this stage.

During the inspection, any minor modification and corrective works if found necessary by the inspecting team, shall be carried out as per the instruction of the inspection team without any additional cost. If the quality of work done is not satisfactory to the inspection team, body fabricator shall do necessary modifications as suggested by inspection team. After completion of the modifications only and next stage work can be started.

Despatch of the vehicle is allowed only after final inspection and clearance given by the inspection team.

The body fabricator shall send the inspection call letters along with the necessary photo proof of completion of each stage well in advance to arrange to depute VSSC team for inspection.

5. LD Clause

In case of any delay from body builder side beyond the delivery periodmentioned in Milestone events & Delivery schedule above, liquidated damages @ 0.5% of the total fabrication cost for delayedvehicle, per week, subject to a maximum of 10% of order value per vehicle for the delayed period will be deducted from Service provider's bill. Any delay from VSSC sidewill be exempted from LD.

6. Payment terms

100%payment within 30days (after deducting LD/PBG if anything applicable) shall be made after completion of work and safe delivery of vehicle back to VSSC with the necessary documents mentionedelsewhere in this document

7. Warranty:

The installed of roof mounted automotive air conditioning units with associated equipment, modified load cabin & driver cabin shall be guaranteed for a period of one years from the date of receipt of vehicle at our site. If any defects are noticed after acceptance of the vehicle during the warranty period, it shall be suitably rectified by the Body fabricator at his cost to the utmost satisfaction of VSSC within the reasonable time. Repair work of the vehicle required during the warranty period shall be done by Body fabricator at TOMD, VSSC,Thumba, Trivandrum using his facilities whenever necessary. if required, Body fabricator may take the vehicle to his premises to carry out repair by submitting a bank guarantee for the value of the vehicle(Rs. 14.00 lakh + cost spend for modification work) and shall be delivered back to TOMD, VSSC,Thumba, Trivandrum free of cost.

8. Performance bank guarantee(PBG):

The body fabricator has to submit an interest free security deposit equivalent to 3% of the total order value in the form of Fixed Deposit Receipt(FDR) or Bank Guarantee which will be refunded after the completion of warranty period (1 year) or shall be adjusted/forfeited against any dues.

9. Vendor eligibility criteria:

- **a.** GST Registered body builder are only eligible in participating in this tender.
- b. The biddermust have executed at least one body fabrication/ modification work during last3 year period.
- c. Body fabricator who has an automobile modification/ fabrication facility within a distance of 500km from VSSC,Thumba, Trivandrumonly eligible to participate in this tender to minimize the time incurred for inspection/clearance during the installation/fabrication works.
- d. Bidder shall have the infrastructure & capability for safely carrying out all the work as mentioned in Annexure-1, Scope of work, terms & conditions mentioned in Annexure-2.

10. Submission of bid (Bidding Format)

a) The bidder shall clearly specify the cost for modification as per the VSSC specification, applicable GST percentage and charges for vehicle collection from VSSC & deliver back after fabrication, etc., separately in the bid.VSSC will not pay any additional charges other than the charge mentioned above.

- b) Transit insurance or any other insurance required while transportation or fabrication shall be taken by the bidder at bidder's risk & cost. VSSC will not reimburse the charges towards the same.
