1. Background

Shri Narayanan PE, Plot No.44, 5th Street, Agni Fairy Land, Thandalam, Chennai-600077 vide application dated 02.12.2019 had sought information in 4 queries related to assigning the Grade Pay of Rs.5400/-(PB-3) in the Pay Band of Rs. 15600-39100 to employees falling in the category of PS, PPS, Sr. Proj. Assistant, Asst. Catering Manager, Asst. Security Officer etc., who were already granted MACP in the Grade Pay of Rs.4800/- & Rs. 5400 (PB-2) . The applicant has filed an appeal dated 22.08.2019 alleging that he has not received any response within the time limit. In the meantime relevant information were collected from the custodian of records and CPIO has furnished the information to the applicant vide letter dated 09.01.2020. There was a delay of 9 days in disseminating the information to the applicant.

2. Prayers in the appeal


The appellant alleged that he has not received any response to his RTI application dated 02.12.2019 within the prescribed time limit.

3. निर्णय/DECISION

On perusal of the records brought before me, it is observed that the information sought for by the applicant was not disseminated within 30 days from the date of receipt of the RTI application. However, it is observed from the records that CPIO has taken maximum effort to gather the information from the custodian of records and disseminated the information to the appellant vide letter dated 09.01.2020. There is a delay of 9 days in disseminating the information in this case, which is not intentional. Since, the information has already been furnished, the appeal petition is closed.
