Sub: Revision of pension - Smt. Sathyabhama T - reg.

On implementation of the 7th CPC recommendations, vide DOS OM No.A.12021/11/2016-I dated 14.08.2016, in VSSC all the employees and pensioners who were granted Non-functional Selection Grade (NFSG) to Grade Pay of Rs.5,400/- in PB-3 under 6th CPC regime were assigned Level-9 in the 7th CPC Pay Matrix and their pay and pension revised.

2. However, in the case of Smt. Sathyabhama T, SC No. 26865, while working as Personal Assistant, she was granted 2nd ACP in PB-2 with Grade Pay of Rs.4,800/- w.e.f. 06.05.2006. Since the Grade Pay of Rs.4,800/- was granted under ACP, she was not eligible for grant of NFSG to the Grade Pay of Rs.5400/- in PB-3 on completion of four years in Grade Pay of Rs.4800/-, in terms of DOS OM dated 24/26.12.2009. Aggrieved by the above, she filed an OA before the Hon'ble CAT, Ernakulam Bench praying to grant NFSG to Grade Pay of Rs.5400/- in PB-3 on completion of four years from the date of grant of Grade Pay of Rs.4800/- in PB-2 under ACP Scheme.



The Hon'ble CAT, Ernakulam Bench vide Order dated 15.05.2012 in OA No. 759/2010 allowed the applicant's prayer and directed the respondents to place the applicant in the Grade Pay of Rs.5400/- in PB-3 w.e.f. 06.05.2010 with all consequential benefits. The Department examined the case in consultation with the Department of Personnel & Training and Ministry of Law and Justice and vide letter No. A.12021/8/2012-I dated 20.12.2012 (copy enclosed for ready reference) conveyed to comply with the Order dated 15.05.2012 of the Hon'ble CAT in respect of the

petitioner, as case specific and not to be quoted as precedent. In the meantime, Smt. Sathyabhama retired on superannuation w.e.f 31.12.2010 as Project Personal Secretary. In compliance with above directions, the pay of Smt. Sathyabhama was revised w.e.f 06.05.2010 by granting Grade Pay of Rs.5400/- in PB-3 and her pension was also revised accordingly. Since grant of NFSG to Grade Pay of Rs.5400/- in PB-3 was based on the Orders of the Hon'ble, CAT and the Department advised to comply with the said order as case specific to Smt. Sathyabhama, while revising pension under 7th CPC, her pension was revised in Level-10 of the Pay Matrix, i.e., the corresponding revised Pay Matrix for the Grade Pay of Rs.5400/- in PB-3 under 6th CPC.

4. Now, the Department advised some of the Centres vide letter dated 28.03.2024 to place the employees/pensioners/family pensioners who were placed in PB3 with Grade pay of Rs.5400/- to Level 9 in 7th CPC and fix the pension with immediate effect. Smt. Sathyabhama was placed in PB3 with Grade Pay of Rs.5400/- based on the Orders of the Hon'ble, CAT and complied with the said Order as case specific, and if her case is also to be placed in Level-9, there is a drop in pension as indicated below:

Notional pay in Level-10	-	Rs.57,800/-
Less notional pay in Level-9	-	Rs.56300/-
Difference in pay	-	Rs.1500/-
50% of the difference in pay	-	Rs.750/-

Thus, there would be a reduction in pension of Rs.750/- per month from 01.01.2016, in case she is placed in Level-9.

In view of the above, the matter may kindly be examined at the Department and further course of action to be taken in the matter may kindly be communicated.



ISRO was formed on August 15, 1969. Dr Vikram A Sarabhai is considered as the founding father of space programmes in India. The main objective of ISRO is to develop space technology and application to various national needs. There are six major Centres and several other Units, Facilities and Laboratories spread across the country.

ISRO has established two major space systems, INSAT for communication, television broadcasting and meteorological services, and Indian Remote Sensing Satellites (IRS) system for resources monitoring and management. ISRO has developed PSLV, GSLV, GSLV-MKIII and SSLV rockets to launch the above mentioned satellites apart from launching the satellites

of other countries commercially. PSLV is the first operational launch vehicle of India. As on May 2023, it had 3 developmental flights and 54 operational flights. 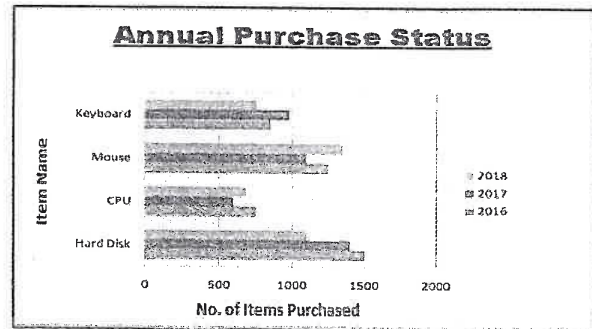
