If the tender could not be opened on the first day due to any technical snag, it will be opened on the subsequent day as per the schedule. Bidders who are desirous of attending the tender opening may make arrangements for attending the tender opening at their cost. **Any Indian agent will be allowed to quote for only one manufacturer / principal and offers from any agent representing for more than one manufacturer / principal will not be considered. Either the Indian agent or the principal /manufacturer can submit bids, but both cannot submit bids, against the same tender for same item.**

This is a two-part tender, Technical & Commercial part (Part I) and Price Part (Part II) shall be submitted separately. The tenderers should not attach any documents containing Price information along with Technical & Commercial Bid (Part I).
