**INVITATION FOR EXPRESSION-OF-INTEREST**

**“Expression-of-Interest to supply medicines to CHSS beneficiaries of VSSC/LPSC/IIST on credit, based on the prescription issued by Authorised Medical Officers of Vikram Sarabhai Space Centre”.**

**1.0 Preamble**

Vikram Sarabhai Space Centre, hereinafter referred to as ‘VSSC’ located at Thiruvananthapuram, Kerala, a lead Centre of Indian Space Research Organisation (ISRO) under Department of Space (DOS), Government of India. VSSC is providing medical coverage to beneficiaries under Contributory Health Service Scheme (CHSS) through various Hospitals empanelled all over Kerala. As per existing practice, the beneficiaries under CHSS can purchase medicines prescribed by AMOs/Empaneled Specialists/Specialists in empanelled hospitals through any licensed pharmacies on cash basis. It is proposed to empanel retail pharmacies at different locations all over Kerala where VSSC AMOs (Authorised Medical Officers) are engaged/empanelled or where empanelled hospitals exist, for supply of admissible medicines to CHSS beneficiaries on credit basis.

**2.0 Scope of Work**

- 2.1 Empanelled registered retail pharmacy outlets (Vendor), shall supply admissible medicines to CHSS beneficiaries on credit basis, based on the prescription issued by AMOs/Specialists/Specialists from the recognized Hospitals of VSSC.
- 2.2 Duration of the empanelment shall be for two years initially, extendable by a similar period in steps of a year each time, subject to satisfactory performance.

**3.0 Responsibilities of vendor**

- 3.1 The vendor shall provide admissible medicine on production of valid prescription issued by AMOs/Specialists/Specialists from the recognized Hospitals of VSSC on credit basis. In the event of non-availability, the vendor may endeavor to supply the medicine within 24 hrs under due intimation to the beneficiary.
- 3.2 The vendor may have to supply high value medicines at recognized hospitals or at residence of senior citizen beneficiary, based on approval/ intimation from VSSC/LPSC/IIST.
- 3.3 The vendor has to ensure proper quality for dispensed medicines.
- 3.4 The vendor shall raise bill of each beneficiary and submit to VSSC accounts not less than fortnightly along with all prescriptions and bill against each transaction with consolidated statement, for the period.
- 3.5 The vendor should submit Bank Account number, IFSC code, name of bank and branch.



#### **4.0 Responsibilities of VSSC**

- 4.1 On receipt of fortnightly claim the same shall be paid directly by VSSC/LPSC/IIST within 15 days from the date of receipt of the bill.

#### **5.0 General**

- 5.1 Vendors registered in India only need to participate.
- 5.2 The Vendor shall possess (a) a shop/outlet (b) valid Drug license from Central or State Drug standard Control organization, (c) GST registration.
- 5.3 Location of the outlet should be within 500 m from the identified location. Ascertaining this distance will be done by VSSC.
- 5.4 EOI shall be preceded by a pre-EOI discussion, mandatorily to be attended (See point 13.0 for more details)
- 5.5 EOI shall contain complete information of the VENDOR, its human resources, infrastructure, assets, financial standing, line of business and credentials.
- 5.6 Any data, information or any other documents that are received from VSSC shall be kept confidential and shall not be tampered with or disclosed to third parties without explicit written permission from VSSC/ISRO.
- 5.7 The Vendor shall submit the EOI in time as prescribed for receipt.
- 5.8 Based on the EOI, if required, VENDORS may be invited for further discussions at VSSC, Thiruvananthapuram for assessment of the capabilities stated in the EOI and for providing clarifications.
- 5.9 Vendor(s) shall submit a declaration in the prescribed format (Annexure- B).
- 5.10 VSSC/ISRO reserves the right to accept or reject Expression of Interest without assigning any reason thereof, at any stage, for one or more locations.
- 5.11 VSSC/ISRO reserves the right to verify all claims made by the VENDOR, which includes inspection and evaluation of infrastructure.
- 5.12 VSSC reserves the right to short close/ terminate by giving a month's prior notice for non-performance. This call for EOI does not carry with it any guarantee of allotment of work.
- 5.13 The Vendor has to give a notice of 3 months to VSSC for alternate arrangements in the event of stoppage.
- 5.14 VSSC reserves the right to enter into parallel contract(s) in any locality with PSU vendors or agencies.
- 5.15 The following documents to be attached while applying for empanelment:
- a. Copy of Drug license from Central or State Drug standard Control organization
  - b. Copy of GST registration
  - c. Proper address of the shop/outlet.
  - d. % discount to be offered over and above MRP.
  - e. Copy of Income Tax Return filed for the last 3 years.

## **6.0 Evaluation of offers**

- 6.1 Vendor is required to quote a standard percentage discount across the board that can be offered to VSSC, as per the format mentioned in Annexure-C. Offer shall be standard percentage of discount across the board.
- 6.2 The final evaluation will be based on highest % of discount being offered by the vendor, if they fulfill other conditions of EOI, not below the minimum discount already enjoyed by VSSC.
- 6.3 Vendors indicating below benchmark percentage will be treated non-responsive.
- 6.4 Only one vendor will be empanelled for one location, as indicated.
- 6.5 Successful vendors will have to enter into a standard agreement with VSSC.

## **7.0 APPLICABLE LAW, JURISDICTION AND ARBITRATION:**

Any disputes, differences, or claims arising from the Contract shall first be resolved amicably through mutual consultation; if unresolved within 30 days, they will be referred to a sole arbitrator mutually appointed (or through institutions designated by the Kerala High Court under the Arbitration & Conciliation Act, 1996), with proceedings in English, shared costs as decided by the arbitrator, jurisdiction limited to courts in Thiruvananthapuram, and the arbitrator's decision being final and binding, while the Contractor must continue the work during arbitration unless directed otherwise by the Department.

## **8.0 PERFORMANCE SECURITY/ SECURITY DEPOSIT**

On receipt of the Contract, Security Deposit for Rs.10,000/- (Rupees Ten Thousand Only) should be submitted in the form of Fixed Deposit Receipt (FDR) drawn in favour of The Accounts Officer, Centre Accounts, VSSC or in the form of Bank Guarantee obtained in a non-judicial stamp paper of Rs.200/-, issued by a Scheduled Bank as per the format enclosed (Form. No. DOS:PM:07) and valid 2 months beyond the completion of this Contract. This interest-free Security Deposit shall be returned to you on successful completion of this Contract or shall be adjusted/forfeited against non- fulfillment of any contractual obligations.

## **9.0 FALL CLAUSE**

The discount offered, under no circumstances, be lower than the highest discount percentage extended by you for identical description to any other party during the period of this contract. If at any time, during the said period, you extend a higher discount to any other customer, it shall be forthwith notified to us and the charges payable under the contract for supply/service done after the date of such reduction of charges coming into force of, shall stand correspondingly reduced.

## **10.0 TERMINATION AND SHORT CLOSING OF CONTRACT/ AGREEMENT**

Under the normal circumstances, Termination/Short Closing of the Contract/ Agreement is not foreseen. However, in case of continued non-performance of the Agreement resulting in inordinate delays and violations of any terms and conditions or that the work performance is not meeting the norms of Quality standards of VSSC, VSSC reserves the right to terminate the Contract wholly or partly by giving written notice of not less than 30 days.

## 11.0 GENERAL:

### 11.1 Submission of Forged Documents:

If any of the Vendor submits any forged or false documents along with their EOI, such Offers will be summarily rejected and such pharmacies will be blacklisted.

### 11.2 Validity:

The Offer submitted by the Vendor shall be valid for a minimum period of **One Hundred and Twenty Days (120 Days)** from the date of receipt. This may be extended if agreeable to the vendor also.

## 12.0 DUE DATE AND DUE TIME FOR SUBMISSION OF EOI

12.1 The due date and time for submission of EOI will be 08.08.2025 at 1700 hours.

12.2 The Vendor shall submit their EOI along with the prescribed Annexures A, B & C and supporting documents, complete in all respects, in a sealed cover superscribing the Ref. No. VSSC/CHSS/EOI/2025 and Due Date 08.08.2025 at 17.00 hours to the Head, Personnel & General Administration, ATF Area, Vikram Sarabhai Space Centre, ISRO PO, Thiruvananthapuram - 695 022.

12.3 EOI received after the said Due Date and Due Time will NOT be considered.

## 13.0 Pre-EOI Discussion.

VSSC/ISRO also proposes to conduct a mandatory Pre-EOI Discussion/ meeting enabling the interested VENDORS to participate and understand the scope of empanelment, terms and conditions. The terms and conditions for dispensing medicines, bills and payment etc. shall be given in detail to the vendors while attending the pre-EOI meeting. Participation in the Pre-EOI Discussion is mandatory and only those VENDORS who participate in the said Pre-EOI Discussion will be eligible to submit their Expression of Interests. Interests of any VENDORS, who have not attended the Pre-Eoi discussion will be summarily rejected. Participation of vendors based out of Thiruvananthapuram can be allowed online (Vendors who wish attend online shall submit intimation to e-mail: [ao\\_chss@vssc.gov.in](mailto:ao_chss@vssc.gov.in) at least one day prior to the discussion date). The date of the Pre-EOI Discussion is **Thursday, 31.07.2025 at 1030 Hours** and will be held at PRO Conference Hall, ATF Area.
