- a. Removal of Brocken or damaged tar sheets/
 —cleaning of roof surface/ Application of adhesive compound/ Pasting of New tar Sheets.
- b. Removal of side window frame of buses or trucks / fixing of new rubber beadings if required/ Application of adhesive compound/ fixing of window frames back to the vehicles.

Sticker Works:
