1. Background

Shri Senthil S, National Water Academy, Sinhaghad Road, Khadakwasala, Pune- 411024 vide application dated 19.12.2019 has sought information related the ISRO Advertisement No. VSSC 312 dated 14.12.2019 for the post of Scientific Assistant (Post code: 1431 and 1432) in four queries. After collecting relevant information from the custodian of records, CPIO vide letter dated 17.02.2020 has furnished the information to the appellant. A copy of the reply letter was sent to the appellant on 19.02.2019 through e-mail. However, before sending the reply, an appeal was received from the appellant on 18.02.2020.

2. Prayers in the appeal

The appellant alleged that he has not received any reply against his RTI application.

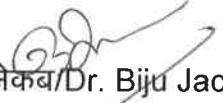
3. निर्णय/DECISION
