1. Background

Shri Rohit Mishra, 312 VPO Naikin, Teh Rampur, District Sidhi, Pin: 486776 vide application dated 06.03.2020 (received by CPIO on 10.03.2020) has sought information related to the number of candidates applied for the post of Technical Assistant (Automobile Engineering) against Advt. No. VSSC-312 dated 14.12.2019, Post code: 1428. After collecting relevant information from the custodian of records, CPIO vide letter dated 04.05.2020 has furnished the information to the appellant. A copy of the reply letter was sent to the appellant on 08.05.2020 through e-mail. However, the appellant has filed an appeal dated 11.05.2020 before the undersigned.

2. Prayers in the appeal

The appellant alleged that no response was received by him against his RTI application within the time limit.

3. निर्णय/DECISION

On perusal of the records brought before me it is observed that CPIO has furnished the reply vide letter dated 04.05.2020. A copy of the reply was sent to the appellant on 08.05.2020 through e-mail. The delay occurred is due to lock down declared by the Government as preventive measure to contain the spread of COVID-19. Hence, the action of CPIO is in order. Since the reply has already been furnished, the appeal petition is closed.

5. This Appeal is disposed of at Thiruvananthapuram on the ...17th... day of June, 2020.

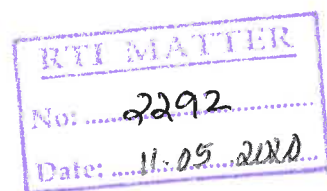
